It is collected in countries recognized as being free of foot-and-mouth disease and rinderpest. The origin of all fetal bovine serum is traceable by lot number, date and country of collection.

Precipitates may develop in this product upon freezing and/or thawing; this occurrence does not impact culture performance.

**Some geographic regions may test higher than 0.300 mg/mL. If this be the case, refer to GGT results less than 10 U/L to ensure FBS purity.
